1. Data protection at a glance

General information

We are aware that the careful handling of your personal data is very important to you. Data protection is therefore of great importance at GRIBI Hydraulics AG.

We are subject to Swiss data protection law in accordance with the Federal Data Protection Act (DSG), as well as any applicable foreign data protection law, especially that of the European Union (EU) with the General Data Protection Regulation (DSGVO). The European Commission recognizes that Swiss data protection law ensures adequate data protection.

The following information provides a simple overview of what happens to your personal data when you visit our website and/or use our services. Personal data includes all data that can personally identify you, such as your name, address, postal address, telephone number, email address, etc. All personal data is covered by this privacy policy.

To ensure that this privacy policy always complies with current legal requirements or to implement changes to our services accordingly in the privacy policy, we reserve the right to occasionally make adjustments to this privacy policy. The new privacy policy will then apply to your next visit to our website.

How do we collect your data?

Your data is collected, in part, by you providing it to us. This may involve, for example, data that you enter into a contact form.

If you provide us with personal data of other individuals (e.g., colleagues, etc.), please ensure that these individuals are aware of this privacy policy and only provide us with their personal data if you are authorized to do so and if this personal data is accurate. GRIBI Hydraulics AG may assume that you have obtained the necessary authorization to disclose personal data of third parties to us. GRIBI Hydraulics AG disclaims any liability for claims arising from an unauthorized disclosure of personal data of third parties. Other data is automatically collected by our IT systems when you visit the website.



These are primarily technical data (e.g., internet browser, operating system, or time of page access). The collection of this data occurs automatically as soon as you enter our website.

What do we use your data for?

We use personal data, in particular, to conduct business relationships with our contractual partners.

A portion of the collected data is used to ensure the error-free provision of the website. Anonymous information is also statistically evaluated to optimize our website and the underlying technology.

What rights do you have regarding your data?

You have the right to obtain information about the origin, recipients, and purpose of your stored personal data free of charge at any time. You also have the right to request the correction, blocking, or deletion of this data. Data Protection

Revocation of Your Consent to Data Processing

Many data processing operations are only possible with your express consent. You can revoke a consent already given at any time. For this purpose, an informal notification by email to us is sufficient. The legality of the data processing carried out until the revocation remains unaffected by the revocation.

Right to object to the collection of data in special cases and to direct marketing (Art. 21 DSGVO)

If the data processing is carried out on the basis of Art. 6 Abs. 1 lit. e or f DSGVO, you have the right to object to the processing of your personal data at any time for reasons arising from your particular situation; this also applies to profiling based on these provisions. The respective legal basis on which processing is based can be found in this privacy policy. If you object, we will no longer process your personal data concerned unless we can demonstrate compelling legitimate grounds for the processing which override your interests, rights and freedoms or the processing serves the establishment, exercise or defence of legal claims. (Contradiction according to Art. 21 Abs. 1 DSGVO).

If your personal data are processed for direct marketing purposes, you have the right to object at any time to the processing of personal data concerning you for such marketing, which includes profiling to the extent that it is related to such direct marketing. If you object, your personal data will subsequently no longer be used for the purpose of direct advertising. (Contradiction according to Art. 21 Abs. 2 DSGVO).

Right to lodge a complaint with the competent supervisory authority

In the event of violations of the DSGVO, data subjects have the right to lodge a complaint with a supervisory authority, in particular in the Member State of their habitual residence, place of work or place of the alleged violation. The right to lodge a complaint is without prejudice to any other administrative or judicial remedies.

Right to data portability

You have the right to have data that we process automatically on the basis of your consent or in fulfilment of a contract sent to yourself or to a third party in a commonly used format, machine-readable format. If you request the direct transfer of the data to another controller, this will only be done to the extent that it is technically feasible.



SSL- and. TLS-encryption

Information, blocking, deletion and correction

Right to restriction of processing

If you dispute the accuracy of your personal data stored by us, we generally need time to verify this. For the duration of the review, you have the right to request that the processing of your personal data be restricted.

If your personal data has been/is being processed unlawfully, you can request the restriction of data processing instead of erasure.

If we no longer need your personal data, but you need it for the exercise, defense or assertion of legal claims, you have the right to request the restriction of the processing of your personal data instead of its erasure.

If you have lodged an objection pursuant to Art. 21 Abs. 1 DSGVO, a balance must be struck between your interests and ours. As long as it has not yet been determined whose interests prevail, you have the right to request the restriction of the processing of your personal data.

If you have restricted the processing of your personal data, this data - apart from its storage - may only be processed with your consent or for the establishment, exercise or defense of legal claims or for the protection of the rights of another natural or legal person or for reasons of important public interest of the European Union or of a Member State.

3. Data collection on our website

Cookies

Some of the Internet pages use so-called cookies. Cookies do not damage your computer and do not contain viruses. Cookies are used to make our website more user-friendly, effective and secure. Cookies are small text files that are stored on your computer and saved by your browser.

Contact form

If you send us inquiries via the contact form, your details from the inquiry form, including the contact data you provide there, will be stored by us for the purpose of processing the inquiry and in the event of follow-up questions. We will not pass on this data without your consent. The data entered in the contact form is therefore processed exclusively on the basis of your consent (Art. 6 Abs. 1 lit. a DSGVO). You can revoke this consent at any time. All you need to do is send us an informal email. The legality of the data processing operations carried out until the revocation remains unaffected by the revocation.



All you need to do is send us an informal notification by e-mail. The legality of the data processing operations carried out until the revocation remains unaffected by the revocation. All you need to do is send us an informal e-mail. The legality of the data processing operations carried out up to the revocation remains unaffected by the revocation.

We will retain the data you provide on the contact form until you request its deletion, revoke your consent for its storage, or the purpose for its storage no longer pertains (e.g. after fulfilling your request). Mandatory statutory provisions - in particular retention periods - remain unaffected.

Request by e-mail, telephone or fax

If you contact us by e-mail, telephone or fax, we will store and process your inquiry, including all personal data (name, inquiry), for the purpose of processing your request. We will not pass on this data without your consent.

This data is processed on the basis of Art. 6 Abs. 1 lit. b DSGVO if your request is related to the fulfillment of a contract or is necessary for the implementation of pre-contractual measures. In all other cases, the processing is based on your consent (Art. 6 Abs. 1 lit. a DSGVO) and/or on our legitimate interests (Art. 6 Abs. 1 lit. f DSGVO), as we have a legitimate interest in the effective processing of the inquiries addressed to us.

The data you send to us via contact requests will remain with us until you ask us to delete it, revoke your consent to storage or the purpose for data storage no longer applies (e.g. after your request has been processed). Mandatory statutory provisions - in particular statutory retention periods - remain unaffected.

Applications

As part of the application process, we process the application documents received and the associated personal data. If the application does not lead to an employment relationship, the application documents will be deleted no later than six months after completion of the application process, unless the applicant has consented to a longer retention period or we have no legitimate interests that conflict with the deletion.

If you apply for a vacancy online via a contact form, a job exchange or a job agency, the respective data protection conditions of these platforms and providers also apply.

4. Analysis tools and advertising

Google Analytics

This website uses functions of the web analysis service Google Analytics. The provider is Google Ireland Limited ("Google"), Gordon House, Barrow Street, Dublin 4, Ireland.

Google Analytics uses so-called "cookies". These are text files that are stored on your computer and enable your use of the website to be analyzed. The data generated by the cookie



Information about your use of this website is generally transmitted to a Google server in the USA and stored there.

The storage of Google Analytics cookies and the use of this analysis tool are based on Art. 6 Abs. 1 lit. f DSGVO. The website operator has a legitimate interest in the analysis of user behavior in order to optimize both its website and its advertising.

IP-Anonymization

We have activated the IP anonymization function on this website. This means that your IP address will be truncated by Google within member states of the European Union or in other signatory states to the Agreement on the European Economic Area before being transmitted to the USA. Only in exceptional cases will the full IP address be transmitted to a Google server in the USA and shortened there. Google Remarketing

The data controller has integrated Google Remarketing services on this website. Google Remarketing is a function of Google Ads that enables a company to display advertisements to Internet users who have previously visited the company's website. The integration of Google Remarketing therefore allows a company to create user-related advertising and consequently to display advertisements relevant to the interests of the Internet user.

Use of conversion cookies and data collection

A conversion cookie loses its validity after thirty days and is not used to identify the data subject. If the cookie has not yet expired, the conversion cookie is used to track whether certain sub-pages, such as the shopping cart from an online store system, have been accessed on our website. The conversion cookie enables both us and Google to track whether a data subject who has reached our website via an Ads ad has generated sales, i.e. completed or canceled a purchase.

Use and analysis of conversion cookie data

The data and information collected through the use of the conversion cookie is used by Google to compile visit statistics for our website. These visit statistics are in turn used by us to determine the total number of users who were referred to us via Ads ads, i.e. to determine the success or failure of the respective Ads ad and to optimize our Ads ads for the future. 5. Plugins and Tools

Google Web Fonts

6. Social-Media

Meta (Facebook & Instagram)
